



VERY VERY SIMPLE TERMS & CONDITIONS

1. The date of the festival is the 15th October 2016.
2. The venue is the Palacio de Congresos.
3. Payments are to be made immediately on receipt of the sign-up form attached.
4. All travel arrangements are to met by the exhibitor, including flights and hotels. GinFesT España can advise on the nearest suitable hotels available in a GinFesT España city/town.
5. GinFesT España is responsible for transfers to and from the destination airport.
6. GinFesT España is not responsible for damages, theft, injury or any other negative impact caused or occurring during the exhibitors time in the city/town of a GinFesT España event.
7. The hours are 2pm – 7pm – 9pm – 3am. All exhibitors will have the use of a barperson, and are thus not obliged to be at their stand all day, but encouraged to.
8. We reserve the right to amend the date of an event giving no less than 5 weeks notice. Full refunds will be given to exhibitors who can not attend the amended date. And reasonable travel costs incurred too.
9. Cancellation by exhibitors:
 - Inside one month – no refund given. Offer of transferring payment to another GinFesT event.
 - Inside two months –50% refund and/or offer of transferring payment to another GinFesT event.
 - Inside three months – full refund given and/or offer of transferring payment to another GinFesT event.
10. Stands are the property of the venue or GinFest España. And as such must be kept clean and tidy.
Any damages incurred will be met by the exhibitors culpable.
11. Modifications to Standard Stands must be agreed by GinFesT España.
12. Mounting and dismantling stands will be responsibility of GinFesT España.
13. Bespoke stand applications must be given no less than one month before an event.
14. All venues will provide, electricity, water, ice, garnishes and apparatus to serve drinks.
15. GinFesT España insures exhibitors against claims by third party liability, for injury, food poisoning, theft and damages.
16. GinFesT España insures exhibitors against fire, explosion or damage by natural causes to stands and personal possessions.
17. GinFesT España does not insure exhibitors against personal theft, damages, or injury incurred at an event.
18. GinFesT España insists on exhibitors using common sense, and the same high standards of practice that would be adhered to in the country of business of the exhibitor.
19. GinFesT España is not responsible for cancellations, amendments and any other change of agreement in respect of flights, hotels and other travel arrangements.
20. GinFesT España is not responsible for damages caused to POS, decoration or other materials couriered or transported by a third party to an event.
21. GinFesT España agrees to buy no less than eight bottles of gin and five crates (24) of tonic from every participating exhibitor no less than one week before the date of the event.
22. GinFesT España takes all proceeds of the takings at a exhibitor stand.



23. GinFesT España takes all proceeds of full bottle sales.
 24. GinFesT España observes the right to amend the running order, entertainment, food stand availability and any other part of the make up of an event.
 25. GinFesT España never guarantees the number of visitors to an event. But a minimum of 300 in total is the norm.
 26. GinFesT España does not guarantee any deals, sales or positive outcomes of any negotiation with third parties during or after an event. But does guarantee to work towards these outcomes.
 27. GinFesT España guarantees all exhibitors a good time and a memorable experience.
 28. GinFesT España is not responsible for any hangovers incurred during or after an event!
